The Mini-Residency in Implant Dentistry

Dr Tony Rotondo and Dr Michael Mandikos are excited to once again stage the latest training program in their Masters Series - The Mini Residency in Implant Dentistry. This new program will be taught by the two well-know Brisbane based Prosthodontists. Each participant will have the opportunity to be taught one-on-one, view live patient procedures and have online access to Alumni course notes.

The Mini Residency in Implant Dentistry is designed to teach each participant the prosthetic and surgical treatment stages for single tooth, multiple teeth and full arch implant reconstructions. The program provides Accreditation with the Prosthodontist Masters Series Alumni and a Certificate for 60 CPD points which can also count towards the MRACDS program.

This program provides training in an "A - Z" manner, starting from the basics and progressing to advanced level prosthetic and surgical concepts. It is suitable for clinicians with minimal dental implant experience who are seeking to enhance their skills and knowledge in this field of dentistry, as well as those with intermediate skills who are wishing to enhance their treatment delivery options.

The Mini Residency consists of 3 modules, each of three days duration (Thursday, Friday and Saturday). Each module has been delicately designed to cover theory and practical aspects of implant treatment. Prior to the first module, each participant will receive some pre-course reading materials. All instruments and materials will be provided at each module, though participants should bring their own loupes.

MODULE 1 Single Posterior and Single Anterior Implants (With Dr Mandikos)

- Diagnosis and Treatment planning
- Imaging and surgical stents
- Planning with the appropriate prosthetic components
- Impression techniques
- Provisional restorations
- Indications for grafting and augmentation
- Practical exercises on impressions and fabricating provisionals
- Selecting the right abutment and crown aesthetics, function and material choice
- Maintenance and management of complications
- Cantilevers and the short span edentulous case
- Live patient demonstrations

Module 2 Full Arch Restoration, All-on-4[®] and Overdentures (With Dr Rotondo)

- Treatment planning and sequencing the full arch case
- How many implants and where should they be placed
- Implant retained or implant supported reconstructions
- Material selection (Zirconia, Metal or Acrylic) and the role of CAD CAM
- Impressions, verification index and frame design and fitting
- Provisionalisation and Immediate Loading
- Practical exercises and Live patient demonstrations
